I understand and agree to the following;

1. Adult Supervision:

I understand that a parent or caregiver must be present and responsible for my child at all times while participating in our Little Knights parent and me programs. This is not a drop off program.

2. Registration Forms:

All registration forms for my child, including without limitation any medical forms (collectively, “Registration Forms”), must be completed before my child attends the Little Knights Program. I understand that Registration Forms must be kept current at all times. I will promptly notify Little Knights of any material changes in my child's health or family situation.

Little Knights “Parent + Me” Program is a 2 month program (8 weeks) (the “Program”), commencing typically the first week of September and concluding at the end of August of the following year (the “Program Term”). Tuition is due for every 2 month session and billed monthly on the 1st of each month regardless of vacations, sick days or extended absences. Little Knights does not give credit for vacations or sick days.

4. Punctuality & Consistency:

Please arrive on time to avoid disrupting the class and your group. Consistency is crucial for your child's development, as it fosters a sense of stability and encourages learning. Therefore, please commit to following all the Little Knights policies and procedures regarding attendance.

5. Due Date for Tuition Payments:

All tuition payments are due on the 1st of each month and are considered late if received after 5pm on the 5th of each month. A late fee of \$25 will be assessed on the 6th day of the month.

6. Tuition and Refund Policies:

Tuition rates and refund policy are posted on our website and at least fifteen (15) days' advance notice will be given prior to any rate change or refund policy changes during the school year. All other school policies are subject to change without advance notice.

- A one-time registration fee of \$50 is due upon initial enrollment of our Little Knights "Parent + Me" Program.
- Little Knights is billed monthly and I understand that once enrolled I will remain in the program and will automatically be enrolled in the next two month session unless I give 15 days written notice.
- No make-up class will be granted under any circumstances. Sorry no exceptions.
- Little Knights will not issue any refunds on any part of unused tuition or registration fee or any other fees or classes that missed by enrollee for any reason.

7. Cancellation Notice:

In the event that I intend to withdraw my child from the Program, Little Knights requires at least fifteen (15) days' prior written notice – the 15th of the month before you wish to cancel.

8. Forms of Payment:

Little Knights accepts cash, check or zelle to accounts@camelotkids.org or payment via our Brightwheel App.

9. Cancellation of Enrollment At-Will:

Little Knights has the right, in Little Knights sole discretion, without cause and without the necessity to provide reason, to terminate my child's enrollment in the program by providing at least one (1) business days' notice to me of such termination.

10. Assumption of Risk Regarding Playground:

I hereby allow my child to play at Little Knights playground, including, without limitation, all play structures located thereon and in the studio and “Womb Room” (collectively, “Little Knights Playground”) and understand by its very nature, the Little Knights Playground carries with it certain inherent risks that cannot be completely eliminated, regardless of the care taken to avoid injuries.

11. Medical Release:

I recognize and acknowledge that there are risks associated with the aforementioned program/event, which may include but are not limited to; falls, contact with other participants, misuse or failure of equipment. I waive all claims that I might have based on any of those and other risks typical in this type of activity. I am aware staff/volunteers may provide support for this program/event, including but not limited to the administration of: first aid, CPR (Cardiopulmonary resuscitation). I authorize any such staff/volunteers to assist me (or my child)

I understand that Little Knights, nor any of its supporting sponsors, assume any responsibility or liability with respect to me (or my child's) participation in this event/program. I agree and hereby waive (on behalf of myself and my child all claims against, and agree to fully release, hold harmless, and indemnify Little Knights.

12. Right to Use Photographs and Video:

I understand that Little Knights staff and parents may take photographs and video of myself and/or my child from time to time to be used for purposes including without limitation: the website, weekly newsletter, and all social media related to Little Knights. I hereby give Little Knights permission to use photographs/sound/video of myself and my child for publicity, promotion, news releases, social media and other public use. This may also apply to any sort of written composition or visual arts of a minor, if published. I hereby release and discharge Little Knights from and all claims arising out of the use of the photograph/video/sound that I or the minor child may have in this regard. *If you do not wish to have your photo taken please initial this box* _____.

13. Choice of Law:

This agreement, all questions with respect thereto and all issues arising hereunder shall be interpreted and resolved in accordance with the laws of the State of California, without regard to the conflicts of law principles thereof and resolved solely by Arbitration. All claims and disputes arising under or relating to this Agreement are to be settled by binding arbitration in the state of [insert state in which parties agree to arbitrate] or another location mutually agreeable to the parties. The arbitration shall be conducted on a confidential basis pursuant to the Commercial Arbitration Rules of the American Arbitration Association. Any decision or award as a result of any such arbitration proceeding shall be in writing and shall provide an explanation for all conclusions of law and fact and shall include the assessment of costs, expenses, and reasonable attorneys' fees. Any such arbitration shall be conducted by an arbitrator experienced in [insert industry or legal experience required for arbitrator] and shall include a written record of the arbitration hearing.
